



MASQUERADE MYSTERY Terms and Conditions

1. Artists may enter a maximum of 2 of their own unaided **ORIGINAL** works, no copies, reproductions or AI.
2. **Work size for 2D works is only A4.** Watercolour Sheets, Canvas Sheets and Cardboard Sheets are provided and must be used for your Art Work.
3. There will be only 100 places for A4 and 20 places for 3D
4. **Work size for 3D is 15 x 15cm for Base and 30cm for height maximums**
5. **No Frames**
6. **No signatures**
7. **No Identifying Marks, front or back**
8. **Price is set at \$100 per art work**
9. **Each work must be accompanied by Artist Registration Card. It clearly labelled with Artist's name, Title of Work, and Contact details.**
10. Works must be for sale. Commission on Sales is 28%. ****GST applied if Artist is GST Registered.**
11. Work/s must be received by **TUESDAY 23RD SEPTEMBER** Registration Card **MUST** accompany your entry. (prior arrangement can be organised). **No extensions.**
12. Work/s must be collected **ONLY** on **SATURDAY 1 NOVEMBER, 9am – 12 noon** (*unless otherwise arranged*). After 6 months, uncollected works become the property of the Bribie Island Community Arts Society and may be offered for sale.
13. Exhibitors accept responsibility for freight and other charges incurred in the delivery or return of an entry. Return details need to be advised separately to the organiser before the exhibition.
14. All entries complying with Entry Conditions will be judged but may not be displayed due to space restriction. **There will be no refunds for work not displayed.**
15. The committee reserves the right to reject unsuitably prepared works including wet, dangerous or delicate works and to not hang work deemed, by the committee, to be damaged, dirty or unsuitable.
16. **Artists will be responsible for satisfying copyright requirements, should they have reproduced from any printed or other material – ref Copyright Act and all amendments.**
17. The judges' decision is final and no correspondence will be entered into.
18. **WHILE ALL CARE IS TAKEN, EXHIBITORS ARE REMINDED THAT BICAS DOES NOT TAKE RESPONSIBILITY FOR LOSS OR DAMAGE OF WORKS.**
19. **INSURANCE OF WORK IS THE ARTIST'S RESPONSIBILITY.**
20. Publicity will be arranged for the Artist of the Month Exhibition and all artists consent to reproductions of their work being used for these purposes.
21. Please carefully check details on entry form as **NO CHANGES** will be made to details after entry received.
22. We welcome all forms of creative expression, **ANY SUBJECT, ANY MEDIUM EXCEPT VIDEO ART or AI.**
23. **There will be 3 prizes awarded, First, Second and Third, judged by the AOM committee. These will be announced at the Morning Tea on Friday 10th October at 10.30am**
